Dear Board -

I wanted to send this out before the meeting tonight in case we have any questions about the virtual shows at tonight's meetings.

First of all, thank you to Tina for working with me trying to get me the information about the payment of virtual show bill virtual so that I could quickly submit their video links to the judge.

Also, I wanted to thank Stephanie Mathieson who was extremely helpful in the production of the April Virtual Show. She helped in many ways from the perspective as a parent of an up and coming Junior exhibitor. Stephanie helped me brainstorm the most efficient way to produce this first virtual show.

So, Stephanie has decided to not be a Show Committee chair unless there is a need or request for her to do so. She has now joined me as Co-Advisor of the NSHA V Youth Group. I am grateful.

What we have learned and decisions we feel are needed, in order to facilitate going forward with these Special Events.

- 1. I know this was stated before, but I want to reiterate this...If we have virtual shows after the May Memories Virtual Show, they will NEVER conflict with NSHA V face to face show (Sept/Oct/Nov).
- 2. We are thinking of having virtual shows throughout the summer. We are viewing this as a fundraiser and as an opportunity for everyone to keep their horse tuned up for our Fall Buckle series.
- 3. In order to keep track quickly of show bill payment is necessary. The reason is we need to know who has paid in order to present video links for judging.
- 4. In order to do this, we have decided to set up nshavyouth PayPal account to allow the money to come in for our direct verification of show bills paid and not burden Tina with keeping track of it.
- 5. In order to have a viable youth PayPal account, we need to link it to a bank account and so we need the information from Tina to do so. We do NOT intend to direct deposit it to the bank account, but only to be able to transfer it to Tina's main PayPal account in a lump sum.
- 6. Transparent accounting of the money coming in for these events are very important. So, Stephanie and I have no problem whatsoever sharing the account information with Tina as the Treasurer of NSHA V.

Halter Horse: NSHA V rule 4, Section 1, Horses must be serviceably sound and shown in hand at the walk and trot. Judging of each horse will be based on conformation 25%, movement 25%, type 10%, quality 10%, substance 10%, presence 10% and manners 10%. Type of halter used must be suitable to the Breed shown. In shows where breed specific classes are offered, the rules of that breed will prevail over the class. Stock type stands square with head level. Saddle type stands up or parks and extends neck.

<u>Halter Horse Solid Color</u>: OPEN TO ALL BREEDS AND SEXES. HORSE TO BE JUDGED on standard outlined above from NSHA V rule 4, Section 1. Solid color is a solid color coat pattern which includes horses with a blaze, snip, and/or stockings such as Buckskin, Bays, Palominos, Chestnuts, or Grays.

ARTICLE VI

ASSOCIATION OFFICERS

Section 1. Officers. Officers of NSHA, V, subject to the By-Laws herein, shall have an elected President, Vice President, Secretary, Treasurer and Director(s) as defined in this Article VI, Section 2. One individual may act as the Secretary and Treasurer simultaneously.

Section 2. Election of officers. A. Elections for new officers of the Association will be held prior to the conclusion of the calendar year, (December 31st), by secret ballot and by majority vote of Senior members in good standing present. **B.** Presidents and Secretaries will be elected at the conclusion of even numbered years (2014, 2016, 2018, etc.) and Vice Presidents and Treasurers will be elected at the conclusion of odd numbered years (2015, 2017, 2019, etc.).

Section 3. Election of directors. **A.** A Region having 50 Senior members in good standing shall be entitled to one elected Director plus an additional elected Director for every 50 additional Senior members in good standing or part thereof. **B.** Directors shall be elected at a regularly scheduled meeting by members in good standing. **C.** Terms of Directors are from election date within the current Fiscal year, (Article III, Section 7, Paragraph B), to the end of the current Fiscal year, December 31st.

Section 4. Qualifications for office. All candidates for office: **1**. must have been Senior members in good standing on or before September 1 of the current membership year and **2**. must have attended a minimum of 50% of the regularly scheduled General membership meetings.

Section 5. Non-qualified candidates. In the event candidates for office do not qualify for an office as provided in Section 4, non-qualified candidates may be elected to office if no qualified candidates are nominated for election.

Section 6. Terms of officers. A. The Association Officers, upon election, shall serve a two (2) year term commencing on January 1st of the new fiscal year following the election. **B.** Directors shall serve as defined in this Article VI, Section 3, Paragraph C.

Section 7. Duties of the president. Subject to the Articles of Incorporation, the laws of the State of Nevada and the Association By-Laws, the President shall be the chief executive officer of the Association and shall have general supervision, direction and control of the business affairs and the officers of the Association. The President shall preside at all Board of Directors and General Membership meetings of the Association and shall confirm all chairpersons of all committees. The President, and/or the Treasurer, shall sign all written contracts approved by the

Board of Directors and shall have the general powers and duties of management, and shall have other powers and duties as may be prescribed by the Board of Directors and the By-Laws.

Section 8. Duties of the vice president. In the absence or disability of the President, the Vice President shall perform all the duties of the President and when so acting shall have all the power of and be subject to all the restrictions of the President's office. The Vice President shall perform other such duties as prescribed by the President, the Board of Directors and/or the By-Laws.

Section 9. Duties of the secretary. The Secretary shall 1. Keep, or cause to be kept, accurate minutes of all meetings of the Region, to include meetings of the Board of Directors and the General Membership. 2. Oversee (for accuracy) all notices of all Board of Directors and General Membership meetings of the Association. 3. Shall maintain a current membership roster containing the names, addresses and email addresses (if applicable) of all members of the Association. 4. Maintain a copy of all minutes of each General Membership meeting to include current membership and nomination lists for riders and horses of the current membership year. (Article III, Section 7, Paragraph A.) 5. Maintain and distribute as necessary all reports. 6. Send membership renewal notification to all members via email prior to December 1st of the current Membership Year. (Article III, Section 7, Paragraph A.) and 7. Perform other such duties as may be prescribed by the President, the Board of Directors and the By-Laws.

Section 10. Duties of the treasurer. The Treasurer shall 1. Keep and maintain, or cause to be kept and maintained, accurate accounts of the financial transactions of the Region, 2. Deposit monies and other valuables in the name of and to the credit of the Association, 3. Sign all checks, drafts and notes of the Region, (in the event the Treasurer is unable to indorse checks and drafts, the President shall indorse all checks and drafts.) 4. Pay all bills and debts incurred by the Region, subject to the approval of the Board of Directors and membership 5. Keep account of receipts and expenditures, which, shall be open at reasonable hours and by appointment for inspection to any member in good standing upon request, 6. Render a financial report to the Board of Directors and General membership at each meeting, and 8. Have such other powers and perform other duties incidental to such office or as may be prescribed by the President, the Board of Directors and the By-Laws.

Section 11. Resignations. A. Any Officer of the Association may resign at any time. Notice of a resignation shall be presented to the President stating reason of resignation and specifying effective date. If no date is specified, it will be effective upon receipt by the President. B. The President of the Association may resign at any time by presenting notice of resignation to the Board of Directors stating reason and effective date. If no date is specified, it will be effective upon receipt by the Board of Directors. C. Any Officer failing to perform the duties prescribed them shall be construed as a resignation, effective immediately and the remainder of the term shall be filled as directed by the By-Laws. (Article VI, Section 13, Paragraphs A–F.)

Section 12. Terminations. A. Any Officer or Director of the Association may be removed from office by two thirds vote of the Board of Directors provided notice of such intended action is posted to the balance of the Board a minimum of ten (10) days prior to action taken. B. The President, following notification to the balance of the Board, may call for a Special meeting (Article V, Section 7, Paragraph B) to decide action to be taken and the remainder of the term shall be filled as directed by the By-Laws.

Section 13. Vacancies. Any vacancies within the offices of the Association, during any term, shall be filled for the remainder of the term as follows:

- A. President's Office: The Vice President shall succeed to office.
- **B**. Vice President's Office: A Successor shall be elected from members in good standing of the general membership.
- C. Secretary's Office: A Successor shall be elected from members in good standing of the general membership. **D**. Treasurer's Office: A Successor shall be elected from members in good standing of the general membership. **E**. Director's Office: A Successor shall be elected from members in good standing of the general membership.
- **F.** Immediate Past President: The Immediate Past Vice President will fill the remainder of the term.


