How does Teleconference Call In meeting attendance work – Teleconference line number works great but using a cell phone coupled with regular blue tooth wireless speaker does not work so great as there is no speaker (difficult for those on the phone lines to hear the meeting). Board will look at purchasing speaker/monitor devise specially made for teleconference meetings to use at next meeting.

- c. Question from member regarding two concerns arising at February Show:
 - i. Announcement made that no coaching from the rails or side lines is allowed. Concern that this is a wide spread practice at upper level show venues, and that coaching from the rail/side lines cannot be restricted. At the February show our Judge called up to the announcer requesting announcement that there be no coaching from the rail/side line. FB moderator will amend announcement made on NSHA V FB page that Show Audience should stand back from rail and that should the Judge request, no coaching from the rail/sideline be conducted.
 - ii. Question from Janet Reidhead re NSHA V rule about attire for English Trail Class states helmet is optional. This was verified and motion by Janet Reidhead with second by Diana Avery that statement be added to the Show Premium. "While NSHA V Show Rules approved November of 2017 makes NOT optional the use of helmet in English Trail class, Exhibitors are asked to comply with request for helmet to be worn."
9. Show Committee Report:
 - a. Show Manager – Job responsibility description in the works.
 - i. Other paid position – Job Responsibilities also in the works
 - b. Whom could be designate as show manager that would be consistent? Members see a value to having a one show manager for each season in order to provide consistency and continuity for 2018 show management.
 - c. Coffee and Donuts – some comments made by exhibitors that they missed morning coffee and donuts outside of the show office. The NSHA V Coffee maker has been returned. Exhibitors/Members are asked to volunteer to bring donuts and/or goodies and NSHAV will provide coffee/condiments.
 - d. Judge chat with Show Committee Chair as she was taking her back to hotel, two items of interest mentioned by February Judge:
 - i. Dressage Judging feasibility by carded breed judges may in fact be challenging for those judges. Those judges who have a USEF card may be more familiar with requirements for judging dressage classes, it would be important to let all judges know dressage classes are being offered at NSHA V prior to their acceptance of their contract.
 - ii. Judge mentioned that in her opinion NSHA V is one of the only Open Breed shows that she has judged at that is truly an OPEN BREED show. The versatility of the Show Class Schedule which includes the opportunity for both Hunt and Saddle Seat exhibitors to show in the English Pleasure classes, the variety of classes (Open, Junior, Amateur, W/T/J and 3 gaited classes with opportunities to show in Halter, Showmanship, Pleasure, Equitation & Horsemanship, Trail, Dressage, Reining and Ranch Riding offered in some combination on both English and Western days makes NSHA V shows truly an opportunity for all breeds to come together and be judged where the best of all breeds can be selected and ranked.
 - e. Trail Warm up – designated time for youth to warm up (tabled for March Meeting)
 - f. Trail and Horsemanship W/T/J elements (NSHA V show rules are silent about this), so what does USEF say? USEF is a huge rule book, our NSHA V has a list of obstacle elements to be offered in our trail classes, but requirement for W/T/J classes are not mentioned. Membership states they do feel it is important for all trail and equitation/horsemanship classes provide opportunities for the exhibitor to demonstrate transition of gaits (Walk to Trot/Jog or vice versus and Walk to Trot/Jog to Canter/Lope or vice versus).
 - g. Member concern (Lisa Gabaldon) raised about being turned away from show because of rumor of equine contagious illness. NSHA V board was contacted by a concerned exhibitor that a break out of an air-borne virus resulting in equine fever, nasal discharge and lethargy had occurred in the week prior to

NSHA V Feb show and would not be attending due to this occurrence. President and Secretary of NSHA V board contact 3 veterinarians in the Las Vegas Regions and the Nevada Dept of AG, Veterinarian Office for advisement.

- i. Results – no quarantine in So. Nevada had been issued
 - ii. Recommendations to check horses attending at show for symptoms of nasal discharge and lethargy and if present share with owners concern about whether showing was in best interest of equine athletes (both affected and non-affected horses for show weekend).
 - iii. No horse was asked to leave the NSHA V show, although it is apparent the exhibitor involved felt that they were being asked to do so. NSHA V President spoke with exhibitor and asked to look at horse involved and horse displayed no symptoms and did show that weekend at NSHAV.
 - iv. NSHA V board apologizes for any misunderstandings or miscommunication by board or show staff. No intention to exclude any healthy horse from showing was or is intended. NSHA V does not at this time require record of equine vaccination, Coggins Test or Health Certificate but remains vigilant to the greatest extent possible for encouraging participation of healthy horses at our shows, for the protection of all participants.
- h. Members in attendance at meeting expressed how much they enjoyed and respected Kathy Callahan-Smith as a judge this past show.

a. **Rule 2 Conduct of Shows, Section 2 B. Hunter:** 1. Riders shall wear hard hats of traditional style, hunt coats, breeches and boots with a distinguishable heel. Spurs are optional. 2. Riders in all classes where jumping is required and when jumping anywhere on the show grounds must wear protective headgear. (~~Exception: Trail Classes~~). The Show Manager must bar a rider without protective headgear from entering the ring for classes in which protective headgear is required and may bar any entry or person from entering the ring if not suitably presented to appear before an audience. 3. All Juniors riding in Hunter, Jumper and Hunter Seat Equitation sections must wear properly fitting protective headgear while riding in the designated schooling and exercise areas, the show ring and while jumping anywhere on the competition grounds. Harness must be secured and properly fitted. Any rider violating this rule at any time must immediately be prohibited from further riding until such headgear is properly in place. 4. NSHA, V and USEF strongly encourages all riders to wear protective headgear passing or surpassing current applicable ASTM (American Society for Testing and Materials)/SEI (Safety Equipment Institute) standards with harness

secured while riding anywhere on the competition grounds. It is the responsibility of the rider, or the parent or guardian or trainer of the junior exhibitor to see to it that the headgear worn complies with appropriate safety standards for protective headgear intended for equestrian use, and is properly fitted and in good condition and NSHA, V, the USEF, Show Committees and Licensed Officials are responsible for checking headgear worn for such compliance.
